### STORAGE & USE INSTRUCTIONS

**Rate:** 0.5 gal per acre mixed with a minimum of 15 gal of water or fertilizer, applied via foliar application. Apply product after harvest.

**Recommended Spray Tips:** Flood jet nozzles or spray gun with yellow, green or white nozzle.

**Storage:** Keep refrigerated between 33-44 F. The product can be stored at room temperature for up to four weeks. Once it is mixed with water, the mixture must be used within four weeks.
